### **Stallion Service and Semen Transport Terms and Conditions**

---

1. This service contract is deemed to be between the owner of the nominated mare and Cold Mountain Stud Pty Ltd and the signatory is taken to represent the owner.
  2. This service contract is valid only if properly completed and the deposit paid in full.
  3. This service contract is valid only for the breeding season specified.
  4. Cold Mountain Stud reserves the right to refuse to accept a booking.
  5. All requests for semen transport are to be made on the Cold Mountain Stud Semen Transport Order Form available from our office or downloadable from our website. This form must be received by us within the time specified on the form.
  6. Cold Mountain Stud agrees to accept the cost of chilled semen transport to any capital city in Australia. Additional costs will be incurred by the breeder for delivery elsewhere.
  7. The breeder/owner of the mare accepts responsibility for all transport and applicable agistment and any veterinary costs relating to on farm breeding.
  8. Cold Mountain Stud whilst exercising due care, accepts no responsibility for the safety of the mare whilst on farm for the purposes of breeding and insemination.
  9. The stallion service fee will be due and payable following an invoice issued upon receipt of a confirmed pregnancy test or after 45 days if not advised of a negative test, whichever is the sooner.
  10. A free return service will be made available if the mare fails to produce a live foal that stands for 7 days provided the mare has been properly cared for during gestation and provided the mare remains within Australia.
  11. A 15% discount to the service fee will be provided for each additional mare under the same ownership during the same season.
  12. This agreement terminates on the death of either stallion or mare.
  13. Cold Mountain Stud may arrange eligibility for progeny of stallions to other organisations' race programs and will make every effort to ensure such eligibility exists. However, Cold Mountain Stud does not guarantee such eligibility and no refunds will be made if such eligibility is not realised.
